Result of the GOGA AGM Election for incoming Management Committee

Unfortunately, without a President, Secretary and Treasurer, GOGA will not be able to legitimately operate as an incorporated association. The Management Committee must have at least 3 members which includes a President, Secretary and Treasurer. Without these positions in place, the Management Committee cannot conduct the business of the Association.

The Association has 30 days from the AGM to ensure key positions are filled and as such GOGA is requesting nominations from members for the vacant positions, in particular President, Secretary and Treasurer. Please can you express your interest in being a member of the GOGA Management Committee by emailing goga@glennie.qld.edu.au. The Management Committee will be in touch regarding appointment to the vacancy through an out of session vote (flying minute) in accordance with the Constitution.

Failure to fill these key positions will require the Association to consider its future and whether the winding up proceedings will need to be explored in accordance with the Constitution and the legislation that governs Incorporated Associations in Queensland.


The meeting dates for 2019 are listed below however, these are flexible and if the meetings need to be moved to a weekday evening to suit Committee Members then this can be arranged.
